Mini-Grant Report

Education Committee Met on November 1st.

- Seven mini-grants were approved for the full requested amount, totaling \$2,440.07.
- Five mini-grants were approved for a reduced amount, totaling \$1900.00.
- One mini-grant was approved with funding offered by the Library from their book fair proceeds.
- Two mini-grants were denied as outside the scope of the mini-grant program.
- A total of thirteen mini-grants were approved. The grand total from the PTA approved for funding from the PTA budget was \$4,340.07, with concurrence form the board for the overage beyond the approved budget. Mini-grants benefiting the total school population represented over 50% of the approvals.

- Budget did not cover prizes for games. Will need to buy prizes next year.

Fall No Fuss Fundraiser

- Total Amount Collected: \$11,500. This number is short of last year and short of our goal.
